## Alaska Attachment & Bonding Associates (AABA) Annual Report

**MISSION STATEMENT:** AABA's mission is to support healthy family attachments and bonds through education and advocacy.

**VISION:** AABA is committed to healthy attachments & bonds for all Alaska children and families.

### **SERVICES/PURPOSE:**

Alaska Attachment & Bonding is a non-profit organization that provides education, training, support and advocacy for adoptive, foster, kinship and parents who care for children with emotional disorders such as Reactive Attachment Disorders (RAD), and professionals who work with this population of children. RAD is an attachment disorder that occurs when bonding is interrupted between the infant child and the parents. The most common causes of disruption are emotional and/or physical abuse of the child. Other causes could include: sexual abuse, alcohol and drug syndrome babies. AABA offers support and referral information to family members and professionals seeking direction.

AABA's areas of focus are:

- PREVENTION of early childhood traumas
- PLACEMENT resource list of Residential Treatment Centers that accept Medicaid
- TREATMENT resource information for the children who experience mental illness
- TRAINING for parents and professionals

AABA believes that healthy attachment and bonding in the first three years of life will promote healthier individuals, that youth and families should have meaningful involvement with the design, implementation and evaluation of any programs that affect their lives, that improving our system of care will take all state, local providers and consumers integrating their resources to meet the gaps in service; and that within this system of care, the

most efficient and effective use of money is to provide encouragement and support while teaching self-advocacy and connecting families.

Our community is becoming aware of the cost of drug and alcohol addictions. A hidden cost is the abuse children experience because of their parents' addictions. Not only are children removed from these dangerous situations, but also these children experience mental health issues themselves. It is AABA's mission to stop this cycle by helping parents and professionals understand effects of early childhood traumas.

AABA offers phone support and referral information to family members and professionals seeking direction. AABA offers bi-monthly newsletters and has been offering a basic source of education for parents and professionals through Attachment Disorder Workshops for the past six years. In addition, AABA has a website ([www.akattachment.org](http://www.akattachment.org)) that brings current information on attachment issues to a growing list of professionals, parents, and other interested parties. ## **HISTORY:**

Two mothers came together to discuss the difficulties each was having in parenting children who had been labeled as having attachment disorders. The idea came about when the mothers decided to use their respective knowledge and resources. One mother came from a teaching background while the other came from a correctional planning of exercise/crafts/recreation of prison populations. They decided to form an organization where other parents with similar problems and experiences could come and find the much-needed help to cope with these difficult children.

Soon other interested individuals came together and a Board of Directors was established. The Board members volunteer their time and talent toward a common goal. On January 12, 1998, Alaska Attachment & Bonding Associates (AABA) became the organization's official name with a 501-c (3) status. AABA is comprised of volunteers, professionals and families who care for children through kinship care, adoption, guardianship and foster care.

*Workshops on Attachment Disorders: July 1, 2008 to June 30, 2009*

Alaska Attachment & Bonding Associates (AABA) has been offering workshops to adoptive, foster, and kinship care parents of children suffering trauma in early childhood and professionals, since 2003. AABA offers scholarships to parents and caregivers.

The workshops received outstanding reviews: "Better understanding of our kids." The workshops were offered in August 2008 and February and May 2009.

Attachment Issues knowledge is important in our community because of the severe neglect and abuse of children. Additional trauma is caused when children are removed from their birth parents' care and placed in a "new" family. The "new" parents are overwhelmed with their children's behavior because of attachment issues. AABA strives to support their parents so they can maintain their children in their homes. AABA's mission's is to support healthy family attachments and bonds through education and advocacy.

*AABA was able to provide two workshops for the adoptive, foster, kinship care, and guardianship parents and professionals who care for children diagnosed with attachment disorder: August 18<sup>th</sup> & 19<sup>th</sup>, 2008 and May 16<sup>th</sup> & 17<sup>th</sup> 2009. Thanks to the support of the Mat-Su Human Services Community matching Grant.*

**Mat-Su Health Foundation: 4-30-08 (Community Wellness)**

Amount: \$10,000

*Sustainability for Marketing & Promotions: May 23, 2008 to June 30, 2009*

This Project is to advocate for People Parenting SED (Severe Emotionally Disturbed) Children. This project benefit's children, who have experienced early childhood traumas, by helping parents' find resources in their community. This project will assist parents keep children in their homes instead of placing them in institutions. Also, finding resources for understanding their children's bizarre behaviors because of mental health issue due to early childhood traumas, parents will be better informed in finding the correct professional help for their children to heal from early childhood trauma.

This project will be developed using radio advertising, PSA's, links with other web-sites, community meetings, and health fairs throughout Alaska and newspaper advertising. The public will become aware of Alaska Attachment & Bonding Associates and recognize the services available to

children and families. The web-site redesigns will reflect the information about services available in Alaska, that help children with Reactive Attachment Disorder, knowledgeable Therapists, where to go for assessments, Residential Treatment Centers that accept Denali Kid Care and Medicaid, and AABA's workshops. The new web-site will include an updated history of AABA, what's available in AABA's lending library, Signs and Symptoms and a definition of Reactive Attachment Disorder, and Newsletters.

Marketing and Grant Writing Courses will help sustainability for Marketing, Promotions and Projected Growth. These courses will be taken by the Administrative Assistant.

AABA had the opportunity to market and promote the workshops on the KMBQ radio station's Community Corners and with KMBQ's PSA's ad package, which provided AABA with 240 radio ads with the support of the Mat-Su Health Foundation (Thank you!) and KMBQ's donation (Thank you! John Klapperich and Becky Nichols). AABA was able to increase the workshop participation by 48%. Awareness of Alaska Attachment & Bonding Associates has increased. AABA had participants at the May workshop that traveled from Missouri and Colorado. AABA Web-site [www.akattachment.org](http://www.akattachment.org) has a new look with up-dated information and more information is being added as it comes to AABA.

**Wal-Mart State Foundation Grant: 8-5-08**

*Two Workshops: Two Two-day workshops about:*

Attachment Disorders (RAD) Part I, Signs & Symptoms of Attachment Disorder, Part II, Assessment & Treatment, Part III, Brain Trauma, Part IV, Creating a System of Care. After the parents and professionals attend the first workshop they may attend a more advanced two-day workshop about Reactive Attachment Disorder. The first advanced workshop was held in May 2009. Reactive Attachment Disorder touches the lives of many, from parents, teachers, social workers, mental/medical providers, child care providers, police, attorneys and judges. The parents often look outside the community to an out-of-State treatment facility when they are unable to find services in their community. The day-to-day life with an emotionally traumatized child often leaves the parents believing they have no other choice than to send these children out-of-State. These workshops address the family's need for assistance and education in recognizing the symptoms and methods that benefit families and keep them together.

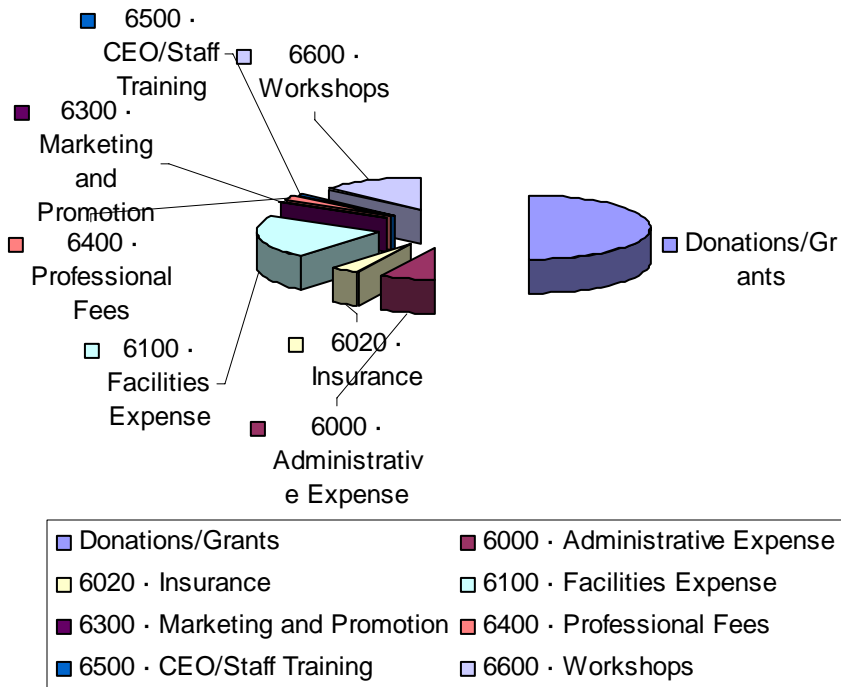

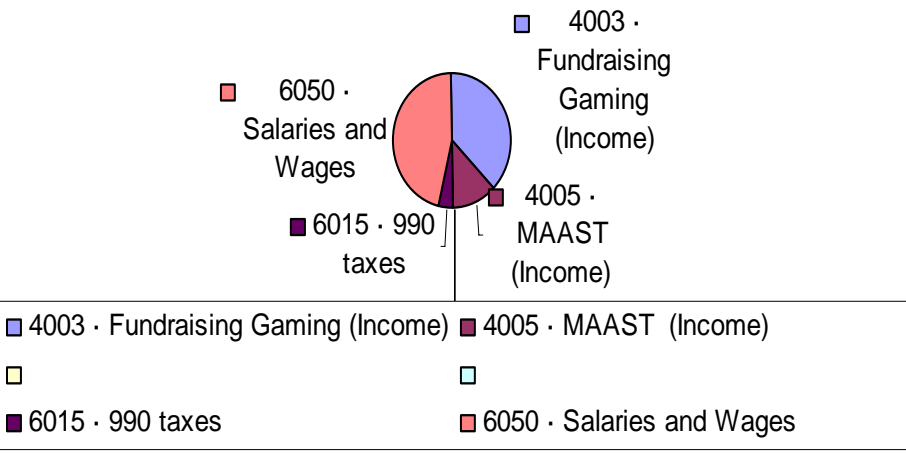
